



# TORFAEN SPRINT MEET



## PROMOTERS CONDITIONS

1. THE COMPETITION WILL BE HELD UNDER W.A.S.A LAWS AND TECHNICAL RULES.
2. OVER THE TOP STARTS WILL BE USED WHEN APPROPRIATE DURING THE MEET.
3. ALL COMPETITORS MUST BE MEMBERS OF AN AFFILIATED CLUB AND AMATEURS AS DEFINED BY W.A.S.A. LAWS.
4. THE PROMOTERS RESERVE THE RIGHT TO LIMIT ENTRIES IN THE INTEREST OF SAFETY AND TIMING OF COMPETITION
5. ENTRIES MUST BE ON THE OFFICIAL ENTRY FORM PROVIDED.
6. CLOSING DATE IS MIDNIGHT FRIDAY 30<sup>TH</sup> May 2008
7. ALL WITHDRAWALS MUST BE NOTIFIED TO THE MEET OFFICE ON LATER THAN 5PM ON THE DAY PRIOR TO THE COMPETITION
8. COMPETITORS WISHING TO WITHDRAW FROM A FINAL MUST INFORM THE OFFICE IMMEDIATELY AFTER THE LIST HAVE BEEN ANNOUNCED OR PUBLISHED
9. MARSHALLING WILL TAKE PLACE AND COMPETITORS MUST REPORT PROMPTLY TO THIS AREA
10. THE SAFETY RULES OF THE POOL MUST BE ADHERED TO AT ALL TIMES. RULES WILL BE ANNOUNCED AT THE START OF EACH SESSION AND ANYONE NOT COMPLYING MAY BE REMOVED FROM THE POOL
11. ALL DAY COACHES PASSESS , TO INCLUDE A MEAL, A PROGRAMME AND SET OF RESULTS ARE AVAILABLE PRIOR TO THE MEET AT THE COST OF £16, **PASSES WILL BE ISSUED AND MUST BE VISIBLE AT ALL TIMES.**
12. INDIVIDUAL TEAMS/COACHES WILL BE RESPONSIBLE FOR THEIR OWN SWIMMERS IN ALL AREAS OUT SIDE THE POOL INCLUDING CHANGING ROOMS
13. ALL VALUABLES/CLOTHING LEFT ON POOLSIDE/CHANGING ROOMS WILL BE ENTIRELY AT THE OWNERS RISK
14. EVENTS WILL BE SWAN IN HEATS, SLOWEST TO FASTEST. H.D.W. EVENTS WILL BE SPEARHEADED
15. FASTEST EIGHT INDIVIDUALS IN EACH AGE GROUP WILL RECEIVE A MEDAL.
16. AN AWARD WILL BE GIVEN TO THE TOP GIRL/BOY IN EACH AGE GROUP
17. ANYONE WISHING TO USE VIDEO EQUIPMENT OR STILL CAMERAS (INCLUDING MOBILE PHONES) MUST REGISTER BEFORE USING THE EQUIPMENT AND THEY WILL BE ISSUED WITH A PASS WHICH **MUST BE VISIBLE AT ALLTIMES**
