1. The competition will be held under W.A.S.A. Laws and Technical Rules. This is a Level 3 meet held under Licence No **06WL3 - 038**.
2. The one start rule will apply, over the top starts will, where necessary or appropriate, be used during this Meet.
3. All competitors must be members of an affiliated Club and Amateurs as defined by W.A.S.A. Laws.
4. The promoters reserve the right to limit entry in the interests of safety and timely completion of the Meet.
5. Entries to be on the standard form provided. No entries accepted without full payment. The entry fee is £3.50 per event, cheques made payable to CITY OF NEWPORT SWIMMING CLUB. Please enclose a stamped self-addressed envelope for return confirmation of accepted entries.
6. Closing date for entries is midnight 11TH NOVEMBER 2006. Entries received after this date cannot be guaranteed consideration. Please note there will be no cards for this competition.
7. All withdrawals must be notified to the Meet Office by no later than 5pm the day before the competition.
8. All day coach's passes, to include full set of result sheets and all programmes, are available at a cost of £5.00 per pass (maximum 2 passes per club). **Passes must be produced on request.**
9. Marshalling will take place, and competitors must report promptly to this area.
10. The safety rules of the pool must be adhered to at all times. Anyone not adhering to these rules (which will be read out at each session) may be removed from the pool.
11. Individual teams/coaches will be responsible for their own swimmers in all areas outside the pool, including the changing rooms.
12. All valuables/clothing etc. left in the changing rooms will be entirely at the owner's risk.
13. Events will be swum in heats, slowest to fastest, with every heat being spearheaded.
14. The fastest six in each event will receive medals. There will be no finals at this event.
15. An award will be given to the boy/girl in each age group with the most points (regardless of number of swims). An award will also be given to the visiting Club with the most points. In the event of a tie, then the award will be given on a count back system.
16. Anyone wishing to use video or still cameras, must register before using such equipment, and will be issued with a camera pass.

17. DATA PROTECTION ACT 1984- CITY OF NEWPORT SWIMMING CLUB uses a computer to record entries and results. By submitting entries and accepting entry to the meet, consent is thereby given (as required under the Data Protection Act 1984) to the holding of personal information in a computer/s. Personal data recorded, such as name, club, date of birth and times may be made public during or after the meet.
18. The promoters reserve the right to remove anybody for misconduct.
19. The promoters reserve the right to remove or amend any of the above conditions as required.
